



**OIL BURNER SERVICE CONTRACT  
Coverage Summary**

**This plan covers an annual burner service cleaning, and any labor on calls made between 7am and 5pm Monday-Friday (excluding holidays) for parts covered below. There will be a \$50 surcharge on any calls made after 5pm, or on weekends or holidays for parts covered below. This contract is good for one full year from contract date. Any service on parts not listed below will have the standard labor charge.**

**TRAINED SERVICE MECHANICS ARE AVAILABLE 24 HOURS A DAY, 7 DAYS A WEEK.**

**Includes: COMPLETE SUMMER OVERHAUL (ANNUAL BURNER SERVICE CLEANING)**

- Clean, lubricate and adjust burner
- Clean nozzle and check oil strainers or filters
- Change oil filter
- Inspect burner controls and adjust
- Vacuum clean boiler or furnace
- Inspect and/or vacuum clean combustion chamber
- Vacuum clean smoke pipe

In addition, this agreement covers the REPAIR and/or REPLACEMENT of the following parts:

**General Terms and Conditions**

**1. Conditions:**

This agreement is a special service plan available to residential customers who use Viking Fuel Oil Company exclusively for all their fuel requirements.

- a. Acceptance of this agreement is subject to an inspection by our service department. It may take place at any time up to and including the first service call.
- b. Any repairs required to initially put the equipment in acceptable condition will be charged at the prevailing rate.
- c. No part or labor is covered by this agreement unless it is specifically listed as "covered"; parts that are obsolete are not covered.

**2. Limits of Liability:**

To the fullest extent permitted by law, Viking Fuel Oil Company is not responsible for indirect or consequential damage and their clean up, nor is Viking Fuel Oil Company responsible for loss or damages due to or resulting from, but not limited to, changes in oil consumption or damages caused by acts of God, strikes, materials or labor shortages, oil and water leakage, power failure, fire, flood, accidents, abuse or misuse of equipment, spontaneous part failure, or other conditions not within Vikings control. To the fullest extent permitted by law, Viking Fuel Oil Company makes no warranties, expressed or implied, including but not limited to any warranty of merchantability or fitness for a particular purpose. Liability will be limited to the repair or replacement of defective parts or service provided under this agreement.

**3. Termination of Agreement:**

The customer may terminate this agreement at any time by providing the company with 15 days notice. The company reserves the right to terminate this agreement without reimbursement to the customer if the customer:

- a. Fails to purchase all of their oil requirements from Viking Fuel Oil Co.
- b. Fails to make payments due the Company for fuel or service in accordance with agreed upon terms.
- c. Fails to remedy conditions identified by the Company as a hazard to life or property.
- d. Permits any person other than Company's authorized representative to service Customers equipment.
- e. Temporarily or permanently suspends automatic oil deliveries.

**4. Renewal/Assignment:**

Renewal of this agreement is subject to annual review by the Company. The Company does not automatically renew Service Contract Agreements each year; the Customer will have to notify Viking for renewal. Customer may assign this agreement to the new owner of Customer' property provided they receive an approval from Viking Fuel Oil Co.
